Dear Vendor,

The Coushatta Tribe of Louisiana announces the 24<sup>th</sup> Annual Coushatta Powwow set for Friday and Saturday, June 7 & 8 at The Pavilion at Coushatta Casino Resort located in Kinder, Louisiana. We are now accepting applications from those interested in participating in this year's Art Market to sell arts & crafts or food vendors.

**Spaces will be 12' x 12' at a rate of \$250 with an option of water for \$25 and electricity for \$35 at 110-volt or \$45 for 220-volt. Fees must be paid in full to guarantee a vendor space. Copy of tribal enrollment card or verification of tribal affiliation is required to complete application.** Fees are non-refundable once accepted. If for some reason your application is not accepted, you will receive a full refund. Spaces will be arranged based on the order the vendor applications are received. Please bring your own tables, chairs, and equipment. Generators are not allowed inside Pavilion. Doors will be locked during closed hours and Security will be on property.

### ARTS & CRAFT

The Coushatta Powwow Committee requests the sale of only authentic American Indian crafts from Native American Indian artists, crafters and traders (Indian Arts and Crafts Act of 1990, P.L. 101-644). The sale of any item with the term 'Coushatta Powwow' is not permitted; only authorized vendors will sell official 'Coushatta Powwow' souvenirs. Novelties, cosmetics, fireworks, or poppers are not allowed. The sale of feathers or bones from protected animals of the U.S. Endangered Species Act is not permitted.

### FOOD

The Coushatta Powwow Committee requests the sale of a variety of foods from American Indian vendors. The **Coushatta Powwow has exclusive rights for the sale of water and soft drinks**; the sale of any canned or bottled drinks not associated with the Coushatta Powwow Committee are prohibited.

**All vendors will check in with a Coushatta Powwow Committee member at The Pavilion on THURSDAY, JUNE 6 from 1 pm – 7 pm or FRIDAY, JUNE 7 from 9 am – 2 pm.**

**Upon check-in, each vendor will receive one packet with two (2) 2019 Coushatta Powwow wristbands and information packet. Additional wristbands must be purchased at regular admission price. Vendor spaces not claimed by 2:00 pm on Friday will be resold. Please have your vendor space open on Friday before 4:00 pm and Saturday before 10:00 am. Vendors may pack up after 10:00 pm on Saturday evening - no vehicles are allowed on the floor until all winners are called or at the discretion of the Vendor Coordinator.**

**\*\* Absolutely no vehicles on floor after 3:00 pm Friday and after 9:00 am on Saturday \*\***
